# Pellegrini ganhou as eleições presidenciais Slovacas

Peter Pellegrini, candidato 5 de esquerda nacionalista eslovaco, saiu vitorioso nas eleições presidenciais do sábado no país, consolidando a influência do primeiro-ministro prorrusso Robert Fico sobre a Eslováquia.

5 Pellegrini, com 48 anos, destacou que a apostas esportivas 2024 vitória representa o apoio para a agenda governamental e 5 o rejeição de um "centro de poder oportunista da oposição", uma referência à presidente liberal Zuzana Caputova demitida. 5

Fico, que assumiu 5 o seu quarto mandato apostas esportivas 2024 Outubro de 2024, deslocou a política externa eslovaca para posições prorrussas e implementou reformas na 5 legislação criminal e nas regulamentações de mídia, suscitando preocupações sobre a erosão do Estado de Direito. 5

Pellegrini obteve 53,26% dos votos, 5 enquanto o candidato oposicionista pró-Ocidente Ivan Korcok obteve 46,73%, segundo resultados de 99,66% das apuradas. 5

Embora os presidentes eslovacos tenham poderes 5 executivos limitados, podem vetar leis ou contestá-las na corte constitucional. Também nomeiam juizes do tribunal constitucional, potencialmente moldando conflitos políticos 5 sobre as reformas de Fico, que procuram reduzir as penalidades para a corrupção. 5

A coligação de Fico, que inclui um partido 5 liderado por Pellegrini, paralisou as entregas oficiais de armas da Eslováquia para a Ucrânia. 5

Fico criticou a interferência percebida por parte do 5 Ocidente no conflito, advertindo contra as nações eslavas serem arrastadas para conflitos umas com as outras. 5

Pellegrini retratou Korcok como um 5 "vaqueiro de guerra" devido ao seu apoio ao armamento da Ucrânia e sugeriu que Korcok possa envolver as forças eslovacas 5 no conflito na vizinha Ucrânia, uma afirmação que Korcok nega-se.
