Depois que Donald Trump negou novamente na segunda-feira, depois de negar as alegações contra ele por E Jean Carroll e acusações sobre estupros ou difamação feitas com sucesso pelo escritor norte americano John F. Kennedy "todas opções estão mines apostas cima da mesa". A advogada de Carroll, Roberta Kaplan. sugeriu anteriormente que ela poderia apresentar uma terceira ação judicial por difamação contra o ex-presidente para comentários ele continuou fazendo sobre Carrol

Durante o feriado do Memorial Day na segunda-feira, Trump postou no Truth Social um longo discurso sobre seus vários envolvimento mines apostas tribunais civis e criminais. Em abril de 2014, uma juíza federal confirmou a decisão dos jurados para conceder Carroll BR R\$ 83 milhões (RR\$ 1 milhão) ao tribunal criminal americano que negou à pessoa mais tarde seu novo julgamento contra ele por parte da justiça americana:

"Feliz Memorial Dia para Todos, incluindo a escória humana que está trabalhando tão duro destruir o nosso país outrora grande", ele escreveu. Ele se referiu Carroll como "uma mulher que eu nunca conheci antes (um aperto de mão rápido mines apostas um evento celebridade há 25 anos atrás não conta!)"

"Ela não sabia quando o chamado evento ocorreu - mines apostas algum momento na década de 1990 – nunca apresentou um relatório policial, nem teve que produzir a'vestida' com quem me ameaçou (mostrava negativo!)... A acusação foi retirada por uma juri!"

Carroll entrou com e ganhou dois processos de difamação contra Trump, que ela disse ter abusado sexualmente dela mines apostas uma loja do departamento Nova York vestiário no 1996. Nos casos judiciais srlroll afirmou ainda as acusações da mulher sobre o caso arruinaram mines apostas reputação

Trump, que está apelando de ambos os casos parece não se intimidar pelo fato do Carroll já ter tido sucesso no tribunal contra ele e continua a fazer comentários depreciativos à mines apostas credibilidade.

Em março, Trump disse à CNBC que "esta mulher não é uma pessoa crível". Ele chamou Carroll de "Sra Bergdorf Goodman", referindo-se a loja onde ele diz ter abusado dela.

"Não tenho ideia de quem ela é", disse Trump mines apostas março.

Em resposta a esses comentários, Kaplan disse que "o estatuto de limitações para difamação na maioria das jurisdições é entre um e três anos".
