Real Zaragoza: Do Famosos só Proprietários de Inter Miami e Jim Miller assumem o Clube Espanhol

No final de 2024, foi anunciada a venda do Real Zaragoza, um clube de futebol da Espanha, para os donos do Inter Miami e Jim Miller. Essa transferência marca uma nova era para o clube, que disputa a Segunda Divisão do sistema de ligas espanhol.

A equipe, frequentemente abreviada como Zaragoza, está sediada em

Zaragoza, Aragão, Espanha

. Seu novo grupo de donos também inclui outros nomes notáveis do mundo dos negócios e do esporte. Esses incluem Jim Miller, sócio e co-chefe do negócio de empréstimos diretos da Ares EUA; Jim Carpenter, presidente do Riverside Management Group; Joseph Oughourlian e Gustavo Serpa.

A Ares, uma empresa líder em palpate vasco e londrina gerenciamento de ativos, está fazendo a palpate vasco e londrina incursão no mundo do futebol como parte dos seus planos de expansão nos mercados esportivos inexplorados, aumentando a palpate vasco e londrina presença global. Para garantir o sucesso contínuo do Real Zaragoza e do Inter Miami, os proprietários dos clubes decidiram se juntar à fúria apenas uns meses antes do início da nova temporada esportiva de 2024.

No momento da compra, a dívida do clube chegava a mais de US\$ 36 milhões. Com essa movimentação financeira, as dívidas poderão ser pagas e o futuro se tornará mais claro para os torcedores e simpatizantes do Real Zaragoza. A notícia trouxe esperança para colocar o clube no centro das manchetes esportivas no início de 2024.

No geral, a empresa de Miller tem mais de US\$ 32 bilhões em palpate vasco e londrina ativos disponíveis para empréstimos. A parte de seu portfólio voltada para os desportos tem como alvo empresas de diferentes tamanhos e nichos, podendo chegar a financiamentos para compras, fusões e aquisições. Dessa forma, espera-se que o clube consiga um sólido futuro financeiro a juro curto e longo prazo. Até o momento, o processo foi mantido em palpate vasco e londrina estrita reservaremindadade a fim de evitar vazamentos na negociação da notícia.

Atualmente, a família de dívidas disponíveis para empréstimos pelo escritório de Miller inclui mais de 110 operações, das quais 38 compras já foram confirmadas. Dessa forma, além dessa transferência, outras possíveis operações estarão por vir no futuro ajudar no crescimento e desenvolvimento do Real Zaragoza com dinheiro sadio para as despesas futuras.

É importante cair no que a compra trará um aréa de margem de manobra para as boas movidas do clube espanhol. Segundo um dos porta-vozes, "estamos construindo algo aqui para durar

muito tempo. Podemos ser uma notícia definitiva e duradoura no futebol espanhol". Com essa transferência, a historia do Real Zaragoza certamente estará em palpite vasco e londrina boas mãos e heading for great times (aludindo a dias de glória).

Eis o que está por trás dessa noticiosa aquisição do Real Zaragoza pelo Inter Miami e pelo Sr. Jim Miller, com reflexos dourados no futuro do clube.

Real Zaragoza: The Famous Owners of Inter Miami and Jim Miller Take Over the Spanish Club  
At the end of 2024, it was announced that the Spanish football club Real Zaragoza had been sold to the owners of Inter Miami and Jim Miller. This transfer marks a new era for the clube, which competes in the Segunda División, the second tier of the Spaish league system.

The team, commonly known as Zaragoza, is based in Zaragoza, Aragón, Spain

. Its new owners also include other notable figures from the business and sports worlds. These includes Jim Miller, co-head of Ares's U.S. direct lending busiology; Jim Carpenter, chairman of the merchant banking boutique Riverside Management Group; Joseph Oughourlian; and Gustavo Serpa.

The Ares company, a leader in asset management, is making its move into the sports world as part of its expansion plans into unexplored markets, increasing its global presence. For the continued success of Real Zaragoza and Inter Miami, the club owners have decided to join arm-in-arm just before the start of the new sportes season of 2024.

At the time of the sale, the club's debt had reached over US\$ 36 million. This financial move now makes it possible for the grub'S debts to be paid and for a clearer future for the Real Zaragoza supporters and sympathizers. The news has brought hope to the cab and placed it in the center of the sporting spotlight at the beginning of 2024.

In general, the Miller firm has over US\$ 32 billion in available assets for underwritings. Its sport-focused portion aims at companies of different sizes and niches, reaching and providing financing for purchases, mergers, and acquisitions. This way, the club can look forward to solid financial prospects over the short and long term. So far, the process has been kept confidential in order to avoid leaks and ensure the best deals.

Currently, the firm's catalogue of underwritings includes more than 110 operations, with 38 having been confirmed already. In addition to this acquisition, possible future operations may also arise to help the creation and development of Real Zaragoza with healthy funds for future expenses.

It is important that the sale will provide maneuvering room for good moves on the part of the Spanish club. According to one clube representative, "we are building something here to last a long time. We can become a definitive and lasting presence in Spankin football." With this acquisition, the future certainly seems promising for the Real Zaragoza, and its story will confidently be in good hands and heading for great times (evoking days of glory).

This is what lies behind the noteworthy acquisition of Real Zaragoza by Inter Miami and Jim Miller, with golden reflections for the club's future.

### **Juiz determina que Brian Wilson, fundador dos Beach Boys, necessita de conservadaria**

Um juiz decidiu que o fundador dos Beach Boys 7 e lendário músico Brian Wilson deve estar sob conservadaria pessoal e de saúde devido a um "transtorno neurocognitivo significativo", conforme 7 a avaliação de um médico.

O juiz Gus T May, do Tribunal Superior de Los Angeles, autorizou a petição apresentada pela 7 família e o círculo interno de Wilson após a morte de palpite vasco e londrina esposa, Melinda Ledbetter Wilson, que cuidava da maioria 7 de suas tarefas e assuntos.

May determined that a conservatorship is necessary 7 for Wilson's personal and medical decisions, as evidence indicates that Wilson consents to the arrangement and lacks the capacity to 7 make healthcare decisions.

May appointed two of Wilson's longtime representatives, publicist Jean Sievers and manager LeeAnn Hard, as his conservators. There 7 were no significant objections raised.

Two of Wilson's seven children, Carnie and Wendy Wilson from the singing group Wilson Phillips, requested 7 through their attorney that all the children be included in a group text chain about their father and be consulted 7 on medical decisions. The judge granted the stipulations.

A doctor's declaration filed with the petition in February said Wilson has a 7 "major neurocognitive disorder", is taking medication for dementia and "is unable to properly provide for his own personal needs for 7 physical health, food, clothing, or shelter".

Sievers and Hard have had a close relationship with Wilson and his wife for many 7 years. The court-appointed attorney, Robert Frank Cipriano, said Wilson acknowledged the need for the conservatorship and trusts the judgment of 7 the two women.

Cipriano's report to the court said he visited Wilson at his "impeccably well maintained residence in Beverly Hills", 7 where he lives with two daughters and a long-term live-in caregiver.

Wilson can move around with help from a walker and 7 the caregiver, Cipriano said, and he has a good sense of who he is, where he is and when it 7 is, but could not name his children beyond the two that live with him. He said Wilson was "mostly difficult 7 to understand and gave very short responses to questions and comments".

The family statement at the time said the decision was 7 made to ensure "there will be no extreme changes" and that "Brian will be able to enjoy all of his 7 family and friends and continue to work on current projects".

Judges in California can appoint a conservator for a person, their 7 finances – referred to as the estate – or both, as was the case with Britney Spears. Spears' case brought 7 attention – much of it negative – to conservatorships and prompted legislative changes.

The Wilson petition did not seek a conservator 7 of the estate because his assets are in a trust, with Hard as a trustee.

Wilson, one of the most deeply 7 revered and acclaimed co-founders, producers, arrangers, and chief songwriters of the Beach Boys, has struggled with mental health and substance 7 abuse issues throughout his career.

He was inducted into the Rock and Roll Hall of Fame in 1988 along with his 7 bandmates,

including his brothers Carl e Dennis
