Complaints About Our Service

The Independent Betting Adjudication Service (IBAS) aims to provide informed and impartial adjudications on disputes that arise between licensed gambling operators and their customers. Our primary aim is to provide a high quality dispute resolution service which meets the needs of our users but we set out to behave professionally, with respect and integrity throughout the process. Similarly we expect those who use the service to treat our employees politely and respectfully too.

We believe we meet our own expectations most of the time. However, if from your experience you feel that we have not got it right, please let us know.

We have a system in place, through which you can let us know if for any reason you are not satisfied with your experience of the organisation.

Complaints: Stage One

If you are unhappy about any IBAS service that relates to communications you have received from an IBAS employee, please make the relevant employee aware to give them the opportunity to clarify any misunderstanding or better explain why a particular position was reached.

Often the relevant employee will be able to give you a response straight away.

However when the matter is more complicated they will give you at least an initial response within 5 working days.

Complaints: Stage Two

If you are not satisfied with the response received or wish to raise the matter more formally, please send an e-mail under the subject heading: "Complaint About IBAS" to complaints@ibas-uk.co.uk where it will be accessed by the IBAS Head of Adjudication.

If it is considered that you have grounds for complaint it will be logged as an official Complaint and you will receive a written acknowledgement within 5 working days.

At this stage the aim will be to investigate your complaint properly and provide you with a reply within 20 working days, setting out how the problem will be dealt with. If this is not possible, an

interim response will be made informing you of the action taken to date or which is being considered.

We hope at this stage you will be satisfied that your complaint has been given due consideration, even if you remain in disagreement with our approach or decision.

Complaints: Stage Three

If after this stage you believe that your complaint has not been properly addressed and the subject of the complaint justifies the attention of the IBAS directors, you can submit a Stage Three complaint in writing to the Managing Director.

If the Managing Director considers the complaint to be justified and improperly addressed at an earlier stage in the complaints process, they will report the matter to the next meeting of the IBAS Board of Directors, which will decide on any further steps necessary to resolve the situation. Therefore if you have completed stages one and two of the complaints process and feel the circumstances of your complaint fall into this category, please address your complaint to:

We may offer a formal apology if we have let you down and where appropriate we will explain what steps we plan to take to ensure the service issue that has affected you should not affect anyone else similarly in future.

Beyond – or in addition to our complaints process – you can consider complaining about our performance to the Gambling Commission, our nominated Competent Authority in accordance with the requirements of British Alternative Dispute Resolution (ADR) regulations.

O primeiro-ministro israelense, Benjamin Netanyahu renegou uma concessão importante de Israel nas negociações do cessar fogo e exigiu que homens 4 armados sejam impedidos para retornar ao norte da Faixa durante um eventual acordo com o governo israelita.

Israel havia concordado anteriormente 4 88 bet permitir aos palestinos acesso totalmente irrestrito

ao norte de Gaza durante um eventual cessar-fogo, mas o primeiro ministro israelense disse a 88 bet equipe nesta semana para exigir que homens armados sejam impedidos do Norte da Faixa como parte integrante dos acordos com os reféns.

A nova demanda poderia potencialmente aumentar o progresso nas negociações de reféns e levanta mais questões sobre a promessa feita por Netanyahu à própria proposta israelense para um acordo que se tornou base das discussões detalhadas.

Na semana passada, um funcionário dos EUA disse que havia "um acordo-quadro" e uma autoridade israelense afirmou ter autorizado seus negociadores a entrar em negociações detalhadas sinalizando o potencial avanço. As conversas foram retomadas na capital do Catar Doha sexta-feira passada. O fim de semana Hamas concordou com comprometer sobre ponto principal para Israel - Que os judeus se comprometem ao cessar fogo permanente no Gaza antes da assinatura dum contrato

Mas uma declaração do gabinete da primeira-ministra israelense no domingo lançou dúvidas sobre se o acordo iria progredir, estabelecendo vários "princípios" que Israel não está preparado para abandonar até todos os objetivos de guerra terem sido alcançados. "

Israel lançou guerra em Gaza há nove meses, como resposta ao ataque do Hamas de 7 outubro que matou 1.200 pessoas e levou mais 250 outros reféns. A Guerra deixou áreas irreconhecíveis no enclave ; desloca quase toda a população da Faixa pelo menos 38 mil mortos na região - segundo o Ministério da Saúde de Israel dissera não terminaria com essa mesma situação até todos os prisioneiros serem libertados ou eliminados por parte dos terroristas islâmicos

O primeiro-ministro de Israel foi até o escritório para comentar.
