Title: Investigation of Judges' Behavior During Trial Involving Sexual Harassment Accusations against David Passamani

The National Council of Justice is investigating the behavior of two judges from the Goiás Court of Justice, Silvânio Divino de Alvarenga and Jeová Sardinha, due to their controversial remarks made during a trial involving sexual harassment allegations against David Passamani. The judges were accused of undermining the woman's credibility, implying that claims of sexual harassment have become a fad, and suggesting that the woman and her partner may have conspired against Passamani.

The investigation began after a ruling was issued by the National Council of Justice, mandating the inquiry of the judges' actions to determine if they violated the Federal Constitution, the Organic Law of the Magistracy, and the Council's own rules, including those concerning the application of a gender perspective in judicial proceedings. The judges have been given 15 days to provide information regarding the allegations.

These comments were made during a session of the 6th Civil Chamber on March 19 whilst discussing the case. One judge questioned whether the woman was not being unreasonable, while another expressed concerns that issues of moral, sexual, and racial prejudice had become a trend. Passamani is the founder of the A House church.

David Passamani was later convicted and ordered to pay a R\$ 50,000 indemnity for sexual harassment against the woman labeled as 'unreasonable' by one of the judges. The woman had sought R\$ 100,000 in moral damages and described in her complaint that she started attending Passamani's church in 2024 and, in December 2024, received sexual messages and video calls from the pastor. Following rejection by the church's direction and a recommendation to forgive the pastor, the woman decided to turn to the judiciary.

Passamani has been denounced for sexual harassment in the past. In March 2024, a veterinarian who attended the pastor's church reported that he had inappropriate conversations about her sex life, expressed a desire to feel her kiss, and had a dream about her. In April 2024, another woman went to the police to denounce the pastor for the same crime. Despite public backlash, the pastor released a video denying the accusations and apologizing to his followers, while the Church Casa released a statement that they were investigating the matter and that Passamani had been temporarily relieved from his duties for medical treatment and family support. However, the court in Goiás ordered the archiving of the police inquiry, although a public prosecutor had requested further investigation. The pastor was denounced again in June 2024 for another sexual harassment crime, which remains under investigation.
