Neto criticizes John Textor after accusations of match-fixing in Brazilian football

The host of the program "Os Donos da Bola," Neto, criticized John Textor, the owner of Botafogo's SAF, after he accused Palmeiras, São Paulo, and Fortaleza of fixing the results of the Brazilian Championship. Neto called Textor a "babaca" and stated that he would not bring up the American entrepreneur on his program. In addition, he questioned the CBF's lack of seriousness and suggested that if they were more rigorous, they would disqualify Botafogo from the Brazilian Championship.

"I'm not going to bring up that babaca, the Botafogo manager, on my program," Neto declared. "If the CBF were just and serious, Botafogo would be out of the Brazilian Championship. Show us the proof that this idiot is manipulating things."

On Monday night, John Textor accused Palmeiras, São Paulo, and Fortaleza of fixing the results of the Brazilian Championship to prevent Botafogo from winning the title in 2024. Textor claimed to have evidence, but did not provide it.

The three clubs responded to the accusations through a statement on Monday night, announcing their intention to take legal action against Textor.

Following the accusations, the CBF released a statement stating that it had not received any formal complaints or evidence of manipulation. The organization also stated that it has zero tolerance for any irregularities in sports and will take appropriate action if evidence is presented.

In an interview, Neto also criticized the CBF and called for more rigorous action from the organization. "If the CBF were more serious, they would have already taken action and disqualified Botafogo from the tournament," he said.

Neto went on to say that the CBF should be more proactive in fighting against match-fixing and should not tolerate such attitudes. "If they continue to let these things slide, it will only get worse," he said. "They need to take a tougher stance."

Neto also praised the attitude of the three clubs that were accused, who promptly responded to the allegations and threatened legal action. "I think it's great that the clubs are taking a stand and defending themselves," he said. "It's important to show that they won't tolerate such accusations without evidence."

So far, neither John Textor nor the Botafogo SAF has made any comments about the matter. The controversy has generated a lot of repercussions and debates within the Brazilian football community, raising questions about the sport's fragility and lack of effective control over such attitudes.

In recent months, there have been several cases of match-fixing in Brazilian football, which has raised concerns about the sport's integrity. Experts argue that the problem is not limited to a few isolated cases and that a deeper reform is needed within the sport to address the root of the problem.

In response to the latest cases, the CBF has announced that it will strengthen its methods for investigating and punishing match-fixing. The organization has also stated that it will work more closely with the police and courts to tackle the issue.

Regardless, the recent cases of match-fixing have generated a lot of repercussions and concern within the sports community and beyond. It remains to be seen how this case and others like it will be resolved and what measures the CBF and other organizations will take to curb this problem within Brazilian football.
