Joe Biden's desempeño en el debate genera preocupación en los demócratas

El desempeño tambaleante de Joe Biden en el debate dejó a los demócratas tan angustiados que algunos están buscando un reemplazo para el presidente de 81 años como el abanderado del partido.

Biden no ha dado indicios de que tenga la intención de retirarse de la carrera, y su campaña ha desestimado enfáticamente la sugerencia. Pero eso no ha hecho mucho para silenciar a los críticos que cuestionan abiertamente si Biden es la persona adecuada para enfrentar a Donald Trump, una figura a la que el presidente y su partido ven como una grave amenaza para la democracia estadounidense.

En el improbable escenario de que Biden decida no postularse, el reemplazo más obvio sería su vicepresidente y compañero de fórmula de 59 años, Kamala Harris. Pero no sería automático y otros candidatos desafiarían a Harris, quien también ha sufrido bajas calificaciones de

aprobación, por la nominación.

Ya algunos demócratas están contemplando a Harris como posibles candidatos en lugar de la vicepresidenta. Entre ellos se encuentran los gobernadores de Michigan, Illinois, California y Maryland, Gretchen Whitmer, JB Pritzker, Gavin Newsom y Wes Moore.

Los demócratas aún no abrazan plenamente a Harris como la heredera de Biden

"Discutir la renuncia de Biden mientras completamente IGNORA a la VP... es una mirada seria a cómo vemos la importancia, la capacidad y la seriedad de las mujeres de color", dijo la escritora Tanzina Vega en X.

Harris, hija de inmigrantes jamaicanos e indios, es la funcionaria electa de más alto rango en la historia de Estados Unidos y la primera negra y la primera asiáticoamericana en servir como vicepresidenta.

Los demócratas, traumatizados por la derrota de Hillary Clinton ante Trump en 2024, se unieron detrás de Biden en 2024 sobre un campo de candidatos más joven, más diverso y más progresista que incluía a Harris. Como candidato, Biden prometió ser un "puente" hacia la próxima generación de líderes demócratas, lo que muchos interpretaron como un compromiso de servir un solo mandato y entregar el bastón a Harris.

Pero cuando llegó el momento de tomar una decisión, Biden argumentó que seguía siendo el demócrata mejor posicionado para derrotar a Trump.

Durante los últimos tres años y medio, la vicepresidencia histórica de Harris ha dividido a los demócratas. La cobertura negativa, parte de ella autoinfligida, combinada con ataques sexistas y racistas, y una cartera de políticas desafiantes, han pesado en la percepción pública de la ex senadora de California. Casi el 50% de los votantes tienen una visión desfavorable de Harris, según el promedio de encuestas de 538, en comparación con el poco más del 40% que la ven favorablemente, cifras que son comparables con las de Biden.

A pesar de un comienzo difícil en su mandato, Harris se ha adaptado al cargo, especialmente desde que se convirtió en la voz líder del gobierno sobre los derechos reproductivos. El lunes, Harris marcó dos años desde la segunda aniversario de la decisión de la Corte Suprema de Estados Unidos que anuló *Roe v Wade* con una advertencia enérgica de que Trump no dudaría en restringir aún más los derechos reproductivos de las mujeres en un segundo mandato.

Harris ha defendido claramente los derechos reproductivos, el tema más fuerte de los demócratas, en contraste
