Resumen de la propuesta de alto el fuego entre Israel y Hamás

Primera fase

- Quedó sin claro quién gobernaría el territorio en virtud del acuerdo.

Tercera fase

- Hamás devolvería 9 los restos de los rehenes que hubieran muerto.
 - Se retirarían los escombros y comenzaría un periodo de reconstrucción de tres a 9 cinco años, respaldado por Estados Unidos, Europa y las instituciones internacionales.
