O órgão independente de revisão policial do Quênia lançou uma investigação sobre a morte da manifestante que foi baleada durante as manifestações anti-impostos copa bet apostas esportivas massa na capital Nairóbi nesta quinta.O incidente provocou indignação generalizada e

intensificou o escrutínio das ações policiais, no meio dos protestos crescentes

Na quinta-feira, uma equipe testemunhou manifestantes sendo gaseados pela polícia e um jornalista foi ferido por botijas. No início da semana foram registradas prisões copa bet apostas esportivas massa na cidade de Nairobi com mais 200 pessoas detidas pelas forças policiais segundo grupos civis do país

"A Autoridade iniciou esta manhã investigações sobre o tiroteio fatal e nossa equipe de investigação estabeleceu contato com a família do Sr. Masai", disse um comunicado da IPOA, que foi divulgado copa bet apostas esportivas setembro deste ano pela agência estatal americana Xinhua (Reuters).

O IPOA pediu "continuou a contenção pela polícia" e exortou os membros do público para serem pacíficos, se comportarem dentro dos limites da lei. "
