todos nossos sonhos fossem suposta erótica suprimida. Uma versão eminentemente revisada de suas teorias influentes deve corrigir vários erros de tradução e desafiar definitivamente a concepção comum de que Freud acreditava que o impulso erótico estava por trás de muito do comportamento humano.

Um novo *Interpretação dos Sonhos*, de Freud, zebet verificatie inglês, por Mark Solms, corrigirá erros de tradução e tentará desafiar definitivamente a concepção comum de que Freud acreditava que o impulso erótico estava por trás de muito do comportamento humano.

"Freud teve uma compreensão muito ampla da sexualidade", disse Solms, um psicanalista sul-africano e neuropsicólogo renomado. "Para ele, qualquer atividade que buscasse prazer zebet verificatie si mesma – qualquer coisa que se fizesse por prazer, zebet verificatie oposição a fins práticos – era 'sexual'."

Comportamentos como um bebê sugar um biberão, ou uma criança chutar um futebol, ou balançar zebet verificatie uma balança, foram descritos por Freud como "sexuais", o que significava que eram fontes pura de prazer.

"Isso estendeu a palavra muito além do uso comum, o que levou a uma significativa compreensão equivocada de suas teorias. No final de zebet verificatie vida, Freud reconheceu isso", disse Solms.

A tradução padrão zebet verificatie inglês de Freud, de James Strachey, foi impressa na década de 1950 e 1960. Agora Solms, um falante de alemão que foi criado na Namíbia, onde uma forma mais antiga da língua ainda é falada, removeu erros e colocou a palavra "sexual" zebet verificatie contexto. "Corrigi alguns erros: Strachey era idoso e zebet verificatie visão estava ruim. Também mudei alguns termos técnicos que estão desatualizados agora e adicionei algumas ensaios, palestras e outras escritas que não estavam na versão de Strachey", explicou Solms.

Há cem anos, as teorias de Freud sobre os impulsos sexuais, o significado dos sonhos e a luta pela liberdade emocional despertaram o nascimento do surrealismo, inspirando o art unsettling de Salvador Dalí, René Magritte e Giorgio de Chirico e as escritas do fundador do movimento, André Breton, que escreveu o *Manifesto Surrealista* zebet verificatie 1924. Mas esses artistas também se enganaram nas teorias de Freud: "Nenhum deles entendeu que Freud era um senhor bastante conservador e não compartilhava de suas inclinações sociais revolucionárias", disse Solms este fim de semana. "Seu gosto pela arte, também, era realmente muito conservador. Freud descreveu Dalí como um fanático."

Enquanto visões de nossos desejos inconscientes alimentaram uma explosão de arte disruptiva, os termos técnicos de Freud foram usados incorretamente zebet verificatie apoio às ideias radicais do surrealismo, argumenta Solms. Longe de promover o caos ou a liberdade sexual, Freud era um pensador socialmente conservador que queria restaurar a ordem, não desafiar convenções.

"O movimento surrealista foi explicitamente baseado nas descobertas de Freud", disse Solms. "Alguns deles, como Dalí e de Chirico, representaram diretamente o mundo interior da mente como é revelado zebet verificatie sonhos, com juntas incongruentes e assim por diante, enquanto outros, como Breton, foram influenciados por aspectos mais profundos de seu trabalho e empregaram escrita automática e desenho automático no modelo do método de associação livre de Freud. Magritte, também, entendeu Freud zebet verificatie um nível mais intelectual."

A edição revisada padrão completa de Solms, um épico de 24 volumes, foi comissionada pela Sociedade Psicanalítica Britânica para marcar o 50º aniversário da publicação do último

Solms não substituiu a tradução anterior de Strachey, pois o vê como "mestre da língua inglesa", que conhecia Freud pessoalmente. Portanto, nas obras atualizadas, "subtle underlining" mostra revisões e adições. Solms espera colocar o grande pensador vienense de volta à nossa conversa sobre sonhos, embora, "há algumas pessoas que prefeririam ver Freud esquecido do que retransladado. Eles gostariam melhor se ele fosse esfregado da história."

Freud originalmente sugeriu que, uma vez que o sono é biologicamente necessário, os sonhos servem a função de nos manterem adormecidos. A experiência alucinatória de satisfação zebet verificatie um sonho, argumentou, impede que nós acordemos, pois "um sonho que mostra um desejo como realizado é acreditado durante o sono, ele elimina o desejo e torna o sono possível".

Descobertas sobre o período de sono de movimento rápido nos primeiros anos da década de 1950 levaram a ataques à teoria de satisfação de desejo de Freud.
